Like most other websites we use cookies in order to improve your browsing experience and our services. This Cookie Notice explains how we use cookies and how you can block or delete cookies should you wish to do so.

1. Our use of cookies

- 1.1. When you enter this website for the first time a 'cookie banner' will be displayed. By continuing to browse the website, you consent to the use of cookies in accordance with this Cookie Notice. However, you can always delete the cookies stored as explained in section 2.
- 1.2. Cookies are small text files placed on your device. These text files enable the collection of data about how our services are being used. There are two main types of cookies:
 - Session cookies are temporary cookies that expire at the end of a browser session, for example when you leave the website.
 - Persistent cookies on the other hand are stored on your equipment/device between browsing sessions until they expire or are deleted. They therefore enable the website to "recognise" you on your return and this in turn allows for a more personalised browsing experience.
